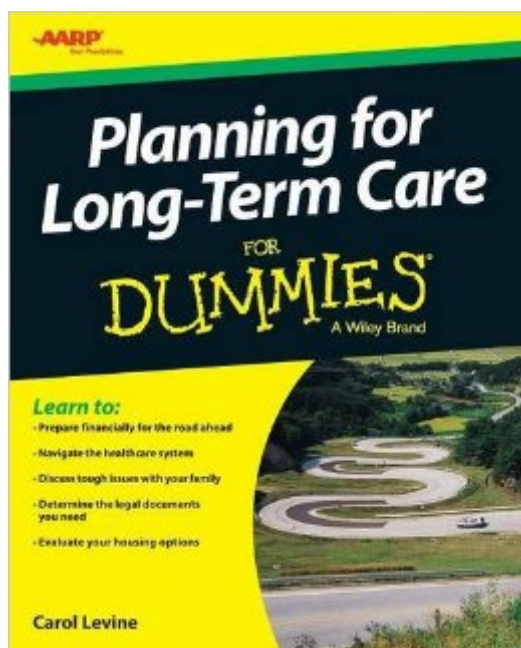

Anyone seeking in-depth information about any of the numerous topics it covers will need to look elsewhere. However, this book will point you to precisely the resources- especially web sites â “ that you need. It is also very easy to read. The topics covered by each chapter are clearly stated, and a full index is provided. Terms including abbreviation (e.g. LTSS, SNF, COB, ADL, STP) are clearly defined. Readers may choose to read the entire book or focus their attention on only the chapters pertinent to them. I, for example, was not interested in multigenerational living situations or planning for veterans, but paid particular attention to chapters on Medicare, Medicaid, home care and nursing homes.
